

**RESOLUTION FOR ADOPTION BY THE BOARD OF EDUCATION
OF THE WAYNE-WESTLAND COMMUNITY SCHOOLS**

2023-24 GENERAL APPROPRIATIONS (BUDGET)

Changes in the amount appropriated by the Board shall require approval by the Board.

BE IT FURTHER RESOLVED, that the Superintendent is hereby charged with general supervision of the execution of the budgets adopted by the Board and shall hold the Assistant Superintendents, Principals and Administrators responsible for the performance of their responsibilities within the amounts appropriated by the Board of Education and in keeping with the Budgetary Policy Statement hitherto adopted by the Board. The Appropriation Resolution is to take effect on July 1, 2024.


