Guidelines

1. Students must be residents of Wayne County.
2. All required immunizations must be completed and up-to-date.
3. Students will not be considered for admission if they have been expelled or if they have been suspended or otherwise released or excluded from their home district for disciplinary reasons during the previous two (2) years.
4. Wayne-Westland Community Schools is not responsible for providing transportation for students under Intra County Schools of Choice.
5. Students accepted under Intra County Schools of Choice may be assigned by the district to any of the District's seventeen (17) elementary schools. Wayne-Westland Elementary building participating in Intra County Schools of Choice (grades K–5) are: Edison, Elliott, Graham, Hamilton, Hicks, Hoover, Jefferson-Barns, Kettering, Lincoln, Madison, Patchin, Roosevelt-McGrath, Schweitzer, Taft-Galloway, Vandenberg, Walker-Winter, Wildwood.
6. If an overcrowding situation occurs and students need to be transferred to another elementary building, Intra County Schools of Choice students will be transferred first.
7. When students enroll through Intra County Schools of Choice at the elementary level, the District may make specific school assignments it deems necessary during the student's educational career.
8. Intra County Schools of Choice students are not allowed to participate in Intra District Schools of Choice, since that option is for resident students only.

Registration Process

1. Parent/Guardian must complete the Intra County Schools of Choice application and deliver in person or by mail by August 25, 2008 to: Wayne-Westland Department of Instruction, 36745 Marquette, Westland, MI 48185
2. Following receipt of the application, the parent/guardian will be notified by mail of acceptance status, and if accepted the school placement assigned by the district. The notification letter will include information regarding the registration process.
3. Required registration information will include a valid Michigan driver's license or picture state ID, proof of residency, a birth certificate and up-to-date immunization records. Registration will take place at the Department of Instruction at 36745 Marquette, Westland, MI 48185.
