# 192.25 PRESENTATIONS – Gray

#### I. Audit Presentation – Clair/Plante Moran

Jamie Essenmacher, Partner (via speaker phone), and Stacie Ebeling, Manager of Plante Moran, presented a PowerPoint of the Annual Audit for the 2023-2024 fiscal year. They shared that the audit resulted in an unmodified opinion, also known as a "clean" audit, meaning the financial statements were presented fairly and by the required accounting standards. Two federal programs were tested during the audit, ESSER and Service Learning Grants and no findings were reported for these programs. However, the audit identified one significant deficiency, which was related to the district's overall audit readiness. This issue was attributed to staff turnover, which affected the preparation for the audit.

#### II. Budget Amendment – Clair

Jewel Clair, Finance Consultant, presented a PowerPoint on the 2024-2025 General Fund Budget Amendment, explaining that the previously presented deficit budget was inaccurate. The amended budget projects the district will break even by the end of the 2024-2025 school year. This budget amendment accounts for the district's salaries, which have been returned to the general fund from ESSER. However, she emphasized the importance of remaining cautious to ensure the district stays on the right financial path.

### III. Student Well-Being – Besek

John Besek, Director of Student Services; Amanda Faughnan, Supervisor of Social Emotional Learning, and Jenny Johnson, Director of Communications presented a plan focused on student well-being, safety, and community engagement. They emphasized building relationships between students and the School Resource Officers (SROs), with a suggestion to look into how to make this connection for multilingual students, ensuring visibility and approachability. The presentation highlighted a shift from expulsions to long-term suspensions and the use of restorative practices when returning from long-term suspension, as well as resolve conflict resolution. They discussed the importance of student voice, partnerships with organizations like Champions and Bright Futures, and it was suggested to involve student councils in decision-making. Additionally, they reviewed safety measures following incidents, such as the fights that took place after the John Glenn Homecoming. It was suggested to consider the possible addition of video monitoring around the field and partnerships with the auxiliary police in the community.
